

Satrio Budihardjo Joedono

Mr. Joedono was born on December 1, 1940, and obtained a first degree in business economics from the University of Indonesia in 1963, a Master of Public Administration from the University of Pittsburgh (1966), and a DPA from the State University of New York at Albany (1971).

He became a government official in the Ministry of Education and Culture in 1963 as a Teaching Assistant in the Management Department of the Faculty of Economics at the University of Indonesia in Jakarta where his interests increasingly turned to Indonesia-specific management. He was made professor of organization theory in 1987, retired in January 2006, and was appointed Professor Emeritus in 2010 <sbjoedono@ui.ac.id.>. Dr. Joedono <sbjoedono@lpem-feui.org> was the only Director of the Institute for Economic and Social Research at the Faculty without an advanced degree in economics became the longest-serving (1970-1978).

He then was Academic Dean of the Faculty in 1978-1982. As Vice Rector for General Administration of the University of Indonesia (1982-1986), he helped overcome student demonstrations and gave administrative leadership to the physical construction of and the relocation of the university's activities to its new campus in Depok, south of Jakarta.

He served (1970-1973) Minister of Trade and (1973-1978) Minister of Research Sumitro Djojohadikusumo as Assistant to the Minister working on institutional issues, and Minister of Research and Technology B.J. Habibie as Assistant Minister for Policy Coordination (1978-1982) and Staff Assistant for Economic Affairs (1986-1988); and then worked on government procurement and economic sector deregulation and privatization for Coordinating Minister for the Economy, Finance and Development Supervision Radius Prawiro as Assistant Minister for Industry and Energy (1988-1993).

Professor Joedono was Minister of Trade from March 1993 to December 1995 during which time he eliminated corruption in textile quota allocations, de-regulated trade, completed Indonesia's negotiations under the Uruguay Round, and signed for Indonesia in the 1994 Marrakech Agreement.

From July 1996 to October 1998 H.E. Mr. and Mrs Joedono lived in Paris where he was Ambassador of Indonesia to France and to Andorra.

In 1998, he was elected Chairman of the Audit Board of the Republic of Indonesia, established by the Constitution as the external auditor of the Government, Parliament, and the Supreme Court. During his term (1998-2004) work procedures at the Board were updated, personnel procedures tightened, modern techniques introduced, and transparency increased, and the Board became a vocal and trusted voice against corruption.

He has been active in non-government organizations since 1970 as a founder-member and member, vice chair, and chair of the boards of trustees, advisors, and supervisors of the Society for Economic and Social Development (BINEKSOS); the Institute for Economic and Social Research, Education and Information (LP3ES); the Indonesian Community of Muslim Intellectuals; and The Habibie Center.

Mr. Joedono is Commander of the Grosse Goldene Ehrenzeichen of Austria and received the Grand Cross of the Order of Oranje-Nassau from the Netherlands. He has been awarded the Satyalancana Wira Karya (Distinguished Service Medal) and Satyalancana Karya Satya 30 Tahun (30 Years Service Medal), and is Adipradana (Grand Officer) in the Order of the Mahaputra of Indonesia.
